**Homeward Bound** : Addison County Humane Society – Homeward Bound is offering boarding for stray dogs similar to the services offered by the Town of Bristol. There are two options – pay \$550 for the year for unlimited dogs or \$400 a year and \$75 per dog after the first 3. The Selectboard indicated interest in the \$400 option but would need to consult with the ACO given the added distance.

**Vermont Cares**: The Vermont Cares annual bike tour to raise funds will be held on June 11, 2016 and part of the route will be through Monkton. This is similar to previous years and Vermont Cares has included a certificate of liability insurance. The Selectboard does not require any additional information.

**Mowing Bids**: The Selectboard has been reminded that it is time to put out mowing bids for the cemetery mowing. The Selectboard authorized Stephen Pilcher to generate that bid and get it in the paper of record for the Town.
