VAUGHN COURT ABANDONED MOBILE HOME: Reviewed letter received from Nadine Scibek, attorney representing Addison County Community Trust, Inc. notifying the town of ACCT's intent to have the mobile home declared abandoned and proceed to dispose of the mobile home. The town needs to decide whether to protect any tax lien it may have on the home. S. Pilcher reported that 2017 taxes were paid. 2018 is not yet due, but is not likely to be paid on an abandoned mobile home. B. Martin will look at trailer and make recommendation to Chair on whether to pursue.

- E. REGIONAL RECYCLING DROP OFF PILOT: Reviewed letter from Addison count Solid Waste Management District soliciting expressions of interest in hosting a regional recycling drop off center. The Select Board agreed that we do not meet the criteria listed for consideration for hosting such a site.
