## **NEW BUSINESS:**

### **DISCUSSION REGARDING TOWN RIGHTS IN THE EVENT OF A SCHOOL MERGER AS SUGGESTED BY E. DOYLE**

A question was raised whether the select board has any jurisdiction in this. In the informational meeting held on Sept 30, the select board was actng as a facilitator for a public forum. M Kelley noted that since she is on the merger committee, she will abstain from any select board votes on the subject. M Kelley reported that the merger committee has pushed out the timing of a public vote on a potential merger until November 2022 (election day). It appears that a vote by the 5 towns on Lincoln's withdrawal from the school district will be held on town meeting day.

### **SUGGESTION FOR CREATING BIKE/WALK LANE ON HOLLOW ROAD**

It was suggested that the road is too narrow to accommodate a separate bike lane, but the Road Foreman will follow up. P. Low measured the road at 5 locations, and the road is close to 25 feet wide. There are many blind turns and there is a lot of agricultural traffic. It may be dangerous for a pedestrian or bicyclist to think they have the right-of-way when there is not room to properly accommodate a dedicated lane. The town could possibly consider using Covid funds to enlarge the road or another location. Car lanes are typically 10 feet wide, but do not extend all the way to the edge of the pavement. P Low noted that the bike lane on Spear St is on a 29 foot wide road.

### **NEW TOWN OFFICES AND LIBRARY STATUS**

### **DISTURBANCE OF SURVEY PIN IN ROW – MCKENZIE**

B. Martin did contact the surveyor about the location of the damaged pin. The surveyor did agree that the pin was placed in the ROW. The board agreed to checking with VLCT regarding placement of survey pins on the ROW.

### **SALVAGE YARDS IN MONKTON**

The state is investigating 3 locations in Monkton. There is one inspector for the entire state.

They have visited one property and a letter outlining an agreement reached with the homeowner has been sent.
