a) Approve minutes of November 17th

4) 2021 Line item amount

- a) Need additional information: the current ANA Fund balance, which has been requested of the Treasurer.
- b) Historically this was 2 cents on the tax dollar and then a similar figure of \$50k/year to the ANA Fund. This was reduced to 35k and then 15k over the past two years to minimize the town tax rate, so residents could better absorb supporting our schools, the new town hall/library and ongoing economic conditions during the pandemic. We do have at least one substantial project that is expected to occur in 2022 in addition to the 2019A project. There have been projects in the past that needed to occur in a short amount of time and the project was only possible due to having a sufficient ANA Fund balance.

- a) Edited a draft of the ANAC write-up for the Town Report.
