**Final Plat Application #2021-02-MAJ of Miranda Fisk for a 2-lot subdivision located at 315 Roscoe Road (Parcel ID 01.228.001.002) in the RA-2/RA-5 Zoning Districts**

K. Perlee received the deed language and added it to the file. The final plat checklist was run. S. Pilcher asked for more details on the Natural Heritage information. M. Fisk explained that there was a possible wildlife sighting years ago, but no protection per ANR.

**Final Plat Application #2022-01-MAJ of Marjorie Susman and Marian Pollack for a 2-lot subdivision located at 3406 Lime Kiln Road (Parcel ID 10.234.010.000) in the RA-5 Zoning District.**

J. DeVries presented the application for M. Susman. A site plan was submitted. The plan looked good but was missing contour labels. J. DeVries stated that the wastewater permit has been submitted to the State of Vermont. Stormwater was discussed. J. DeVries submitted a letter sent to Rick Oberkirch, a State of Vermont permit specialist, asking for clarity if a permit is needed. It was discovered that a curb cut application has not been submitted. K. Perlee provided M. Susman with the application.

2. Wastewater permit be approved by the State of Vermont
