1) Call to Order - Laura called the meeting to order at 6:30pm.

- 2) Approve minutes of the April 12th meeting:
  - Laura moved to accept the minutes of April 12th, 2023 as written. Susan seconded. There was no further discussion. The vote was (5-0-0).

### 3) Updates:

- ARPA mapping status project is coming along well and is largely on-track

- Raven Ridge: parking, bobcat closure, conservation & rec Susan has prepared a note for The Nature Conservancy regarding some people going into the closed areas. Some may have come from the north (no signs) rather than south.
