## **Town Plan**

- 1) Forest Integrity: Ivor Hughes, Marilyn Cargill and Wendy Sue Harper have been working on fine tuning the verbiage. Maps have been added and referenced.
- 2) A motion was made by Wendy Sue Harper and seconded by Ivor Hughes to accept the amended Housing Stock and Census amended and corrected information. The motion was unanimously passed.
- 3) The new "Forest Integrity" section is added to meet Vermont Act 171 requirements. Ivor Hughes made a motion to accept the section and Peter Close seconded the motion. The motion was unanimously passed.
- 4) Wetlands: Maps added and named three large wetlands. Legend needs to be added. Motion was made by Ivor Hughes to amended Wetlands section. Peter Close seconded the motion. The motion was unanimously passed.
- 5) Typos and Grammatical error corrections: Peter Close made a motion to accept all corrections. Wendy Sue Harper seconded the motion. The motion was unanimously passed.

Ivor Hughes will prepare legends for maps. The heading will be fixed by Wendy Sue Harper and Marilyn Cargill.

6) Accept the town plan as it has been amended. Ivor Hughes made a motion to accept the Monkton Town Plan, as amended, with the understanding that the legends and headings will be corrected. Peter Close seconded the motion. A vote was taken, and the motion passed by unanimous vote.
