The meeting was called to order by Marilyn Cargill at 7:01pm.

Minutes: The minutes of 12/05/2023 were moved by Ivor Hughes and seconded by Mike New. Peter Close made a motion to approve as amended. Mike New seconded the motion. The minutes were accepted as amended - unanimously.

- I) Arrowwood mapping project is completed. Ivor Hughes sent each member a digital copy. Anne Miller said that the Conservation Commission is working on the Natural Heritage map for the town plan.
- II) Stephen Pilcher said that he is working on storage of digital maps. Town website is currently offline. Ian Schultz is working to restore it.

III) Zapata Courage; District Wetland Ecologist, Vermont Department of Environmental Conservation joined our meeting via Zoom:

She said that she had reviewed our Town Plan. She then offered several points for consideration using a slide show. Town Plans are not regulatory but living documents to reflect the "changing vision of the community." "Zoning is a Town regulatory process concerning use and development." State Rules are by default without regard to lack of town zoning.

As of 2014 VT groundwater is considered by State law to be a resource held in public trust. Intermittent streams/ Class III wetlands are not regulated by the state.

Consideration: Do not tie policy to wetland mapping.

Class I wetlands must be petitioned and reviewed. Monkton does not have any Class I Wetlands. Class II wetlands are the majority of wetlands in the state- they are ½ acre or larger.

Zapata Courage concluded and left the meeting at 8:35pm.
