RE: Vermont Gas Systems, Inc.: Addison Natural Gas Project Certificate of Public Good – Section 248 Permit Application

Dear Neighbor:

As you may know, Vermont Gas Systems, Inc. ("Vermont Gas," "VGS" or the "Company") is Vermont's only natural gas utility and has over 45 years of experience building, operating and maintaining a natural gas system serving approximately 45,000 Vermont customers in Franklin and Chittenden Counties. Vermont Gas is preparing to expand its natural gas system into Addison County (the "Addison Natural Gas Project" or "Project"). The Addison Natural Gas Project will provide significant economic, environmental and reliability benefits to Vermont as well as advance Vermont Gas's longer-term goal to extend service to the Rutland area.

The Project includes the following principal components:

- (1) Approximately 43 miles of new 12-inch transmission pipeline, extending from a new tie-in to be located at Vermont Gas's existing 10-inch mainline north of Severance Road in Colchester (the "Colchester Tie-In"), Vermont, to the intersection of U.S. Route 7 and Exchange Street in Middlebury, Vermont (the "Transmission Mainline");
- (2) Approximately 5 miles of new six-inch distribution mainlines ("Distribution Mainlines") that will extend distribution service to Vergennes (4 miles) and Middlebury (1 mile); and
- (3) Three new pressure regulation stations ("Stations" or "Gate Stations"), one located near Route 2 in Williston to reinforce the existing distribution system, one on Plank Road in New Haven, and the third just south of the intersection of U.S. Route 7 and Exchange Street in Middlebury.

With this letter, Vermont Gas is providing you notice of its submittal today with the Vermont Public Service Board of a Petition for a Certificate of Public Good pursuant to 30 V.S.A. § 248 authorizing construction and operation of the Project. You are receiving this notice because your property, as recently identified on the town's certified grand list, adjoins property where the
