

MOUNT ABRAHAM UNION HIGH SCHOOL DISTRICT NO. 28

WARNING

The legal voters of the Towns of Bristol, Lincoln, Monkton, New Haven and Starksboro, being of Mount Abraham Union High School District No. 28, are hereby notified and warned to meet at the official polling places in their respective Towns, on Tuesday, November 4, 2014, between the hours of nine o'clock (9:00) in the Town of Bristol; seven o'clock (7:00) in the Town of Lincoln; seven o'clock (7:00) in the Town of Monkton; seven o'clock (7:00) in the Town of New Haven; and seven o'clock (7:00) in the Town of Starksboro; in the forenoon (a.m.), at which time the polls will open, and seven o'clock (7:00) in the afternoon (p.m.), at which time the polls will close, to vote by Australian ballot upon the following Article of business:

ARTICLE I

Shall bonds or notes of Mount Abraham Union High School District No. 28 in an amount not to exceed Thirty-Two Million Six Hundred Twenty-Five Thousand Dollars (\$32,625,000), subject to reduction from available state and/or federal construction grants-in-aid and appropriations, be issued for the purpose of financing the cost of making certain public improvements at the Mount Abraham School Building in the Town of Bristol?

State funds may not be available at the time this project is otherwise eligible to receive state school construction aid. The District is responsible for all costs incurred in connection with any borrowing done in anticipation of the receipt of school construction aid.

Upon closing of the polls, the ballot boxes will be sealed, re-opened at the polling place in the Town of Bristol, the ballots commingled and publicly counted by representatives of the Boards of Civil Authority of the Towns of Bristol, Lincoln, Monkton, New Haven and Starksboro under the supervision of the Clerk of the Mount Abraham Union High School District No. 28.

The legal voters of the Mount Abraham Union High School District No. 28 are further warned and notified that an informational meeting will be held for the purpose of explaining the subject proposed school building improvements and the financing thereof on Monday, October 27, 2014, at 7:00 p.m. at Mount Abraham Union High School in Bristol, Vermont.

The legal voters of the Mount Abraham Union High School District No. 28 are further notified that voter qualification, registration and absentee voting relative to said special meeting shall be as provided in Sections 706u-706w of Title 16, and Chapters 43, 51 and 55 of Title 17, Vermont Statutes Annotated.
