- 1) Call to order Jessica called the meeting to order at 6:37pm.
- 2) Agenda additions/changes and Minutes taker
  - No additions/changes; Jaime will be the minutes taker tonight.
- 3) Approve minutes of 25th Sept 24 meeting uploaded to this link
  - There was no meeting in October. Our last meeting was on Sept 25th.
  - Steve moved to approve the minutes of September 25th, 2024 as written. Jessica seconded. There was no further discussion. All were in favor (3-0-0).

## 4) Updates:

- Town Forest Update
  - The community process to develop a management plan for the property is underway. There has been a kickoff meeting and sessions on dogs, horses, hunting, trapping, mountain bikes, snowmobiles, and races/fitness events so far. Sessions remaining are on Sunday 11/10 on Extraction (timber harvests, foraging, sugaring), on Saturday 11/16 on Visual/Aesthetics (Art/sculpture, Interpretive trails, Signage), and on Wednesday 12/4 (continuation of the Hunting/Trapping session).
  - The purchase of the land is expected to be complete in the next few weeks!
- Operational Guidelines to be considered @ Nov 12 Selectboard meeting
- Raven Ridge: parking, conservation & rec, back trails
  - Trails are in great shape; existing storm damage has been partially cleared on the northern end (downed trees); some cars were there after dark.

## 5) 2025 Budget

- Town Forest remaining funds to be disbursed in 2024 for project closing:
  - Remaining amount allocated for appraisals in 2022 due @ closing: \$1,812.50.
  - Amount allocated in 2023 due @ closing: \$45,000.
- Project expenses in the pipeline; Other expenses discussed, will continue budget consideration at our next meeting.
- Potential future projects could involve the wildlife crossing uplands.
