  - REPRESENTATIVE FRED BASER VISIT: At his request, Rep. Baser attended the meeting to update the board on issues under consideration at the state legislature and to respond to Select Board questions and concerns.
  - AUTHORIZE FINANCIAL REVIEW: **A. Layn moved and R. Parker seconded to retain Pace & Hawley to perform a review of the town's finances. Voted and approved 5-0-0.**
  - PERSONNEL POLICY UPDATE: J. McNerney described two proposed changes to the Personnel Policy, one to clarify intent of a section, and another to bring our sick pay policy into line with state regulations. **H. Boisse moved and R. Parker seconded to adopt the Personnel Policy as amended. Voted and approved 5-0-0.**
  - NATURE CONSERVANCY CURB CUT: Reviewed application for a curb cut by the Nature Conservancy to at the start of their boardwalk to the Raven's Ridge Natural Area on Rotax Road. **J. McNerney moved to approve the curb cut, A, Layn seconded. Voted and approved 5-0-0.**
