- **NEW BUSINESS:**
 - INTERVIEW ZONING ADMINISTRATOR CANDIDATE:
At 7:45, **B Martin Moved and J Mc Nerney seconded to enter executive session to interview a candidate for Zoning Administrator. Voted & approved 4-0-0**
At 8:17, **R Parker moved and B Martin seconded to exit executive session. Voted and approved 4-0-0.** No further action taken.

 - REVIEW GRANT APPLICATION WITH STATE OF VERMONT FOR POSTING OF HIGHWAY SIGNS – STP HRRR(24):
R Parker moved and J Mc Nerney seconded to sign the finance and maintenance agreement with the State of Vermont for replacement and maintenance of road signs covered in this grant. Voted and approved 4-0-0

 - DISCUSSED ANIMAL CONTROL OFFICER OPENING. We currently have no Animal Control Officer, and are still looking for a place to lodge impounded animals.

 - TOWN MODERATOR COMPENSATION: **R Parker moved and B Martin seconded to continue paying the town moderator at the BCA hourly rate. Voted and approved 4-0-0.**

- **OLD BUSINESS:**

- **REPORT ON SITE VISITS WITH VTRANS REGARDING SAFETY CONCERNS ON SEVERAL TOWN ROADS:**

Bus Stop Ahead sign requested on Monkton Rd – H Boisse and L LeCompte met with VTRANS Repmeasurements were taken which confirmed that the location meets the federal guidelines for school bus stops. No further action taken.

Monkton/Bristol Rd intersection – Concern expressed that sight lines were poor for trucks and other farm equipment operating at this intersection. VTRANS Representative had two suggestions: (1) Consider installing a flip up sign which could be opened when farm activity was taking place, or (2) Town should clear trees which have grown into the Town Right-of-Way and are obstructing visibility.

Hill on Mountain Rd: – VTRANS Representative suggested widening the road to the west to allow more room for vehicles to get over to the side when approaching the hill. This recommendation to be discussed with Road Foreman for inclusion in future Highway Dept. Budget

J McNerney moved and R Parker seconded to appoint Jessica Demeritt to a one-year term as Recycling Coordinator and Ian Shultze to a one-year term as Webmaster. Voted and approved 4-0-0
